# GCOW SPOTLIGHT COURSE: FAIRFIELD HILLS GC

Fairfield Hills Golf Course has a unique design inspired by some golf professionals who believe that to "Grow the Game", courses need to offer more flexible play and a more enjoyable experience for the average golfer. With three sets of tees, and 3, 9, 12 or 18-hole layout options, Fairfield Hills provides a fun and affordable experience for players of all ages, abilities, and time constraints. It is not too difficult for beginners and kids yet challenging enough for more experienced players.

Fairfield Hill Golf Course is a public course that opened in 1997. The original 9-holes were designed by Harold Spink. In 2004, the facility was expanded, adding a new clubhouse and a large driving range. Jim Tracy purchased the course in 2014 to add golf as an amenity to the Fox Hill RV Park & Campground he owned next door. Over the past nine years, the facility has been transformed into a family-friendly golf course where Baraboo area golfers and visitors to the Wisconsin Dells have more golf options and the opportunity to improve their game on the area's largest practice range.

Many golfers today are finding it hard to spend 5+ hours playing 18 holes. To address this trend, some professionals are encouraging exploring 12-hole layouts or redesigning our existing holes to offer the option to play various layouts in less time. When Fairfield Hills Golf Course opened 3 new holes in June 2018, it became the area's first and only course to offer golfers the option to play 3, 9, 12 or 18 holes. The addition created a fun, casual, and far less time-consuming experience for golfers.

Fairfield Hills added 3 holes and they were a great addition to the existing 9 holes. The new holes included a short 126-yard par three, a 405-yard par 5, and a 283-yard par four. The par 5 11th hole provided a more challenging golf experience. The new holes also gave golfers the option to hit a bucket of balls on the practice range, take some practice putts on the putting green, and then go play 3 holes with the entire experience taking just 60 to 90 minutes.

Owner Jim Tracy states, "The new course design has been a big success with most golfers selecting the new 12hole option where they can play in about 2.5 hours. The addition of the 3 new holes gave their golfers more options that fit their schedule and interest. The new layouts is appealing to golfers of all levels and business groups which often include people who are not frequent golfers."

Fairfield Hills Golf Course & Range has consistently been selected one of the top 9-hole golf courses in the state, winning over a dozen GCOW awards including several Appearance and Maintenance, Marketing, and Teacher of the Year awards. In 2018, Fairfield Hills was selected Wisconsin's 9-Hole Course of The Year.
