### GCOW SPOTLIGHT COURSE: PINECREST GOLF COURSE

Nestled away in the Northwoods of Wisconsin, Pinecrest Golf Course is a hidden gem within the village limits of Dallas, WI. A full irrigation system was installed as well and thus, Pinecrest, became a community icon. The course was updated as the years went on to what it is today. Pinecrest rapidly changed about 13 years ago when the golf course acquired a full beer and liquor license. Now, with the sale of alcohol, the previous owners could focus on starting a restaurant as well. In 2018, the facility and maintenance shops were overhauled and brought into the modern age. A full restaurant accompanied by a

40-person capacity dining room allowed Pinecrest to host celebrations, parties, and graduations. The maintenance shop was made bigger, and equipment was upgraded as well.

Whether you are an experienced golfer looking for a fresh course with a beautiful view, a family looking for outdoor recreation, or trying your hand at golf for the first time, Pine Crest Golf Course and its crew of knowledgeable, helpful staff invite you to join us for a fun and satisfying experience. You will enjoy a beautiful course set within a mature wooded area, complete with water hazards and sand bunkers. But don't worry: Our hazards are as easy on the eyes as they are a challenge to your score. We pride ourselves on offering you a course that is lovely to look at as it is fun and challenging to play.

Fast forward to the present day and we offer bingo on Thursdays, Fish Fry on Fridays, leagues on Monday and Tuesday nights, and live music one Saturday per month! We take pride on our customer satisfaction as well as our course conditions. Our owner is a UW-Stout grad who is Stout Proud! He hopes to take what he learned from his experiences as Stout and as a GM at Big Fish Golf Course in Hayward to better Pinecrest and make it a community treasure for years to come.
